TERMS AND CONDITIONS

BOOKINGS REQUIRMENTS I The Room Hire fee is required upon booking. The room hire fee includes room set up and bar staff for 3 hours. Function Room bookings are subject to availability. Function Room available until 3pm on Fridays. Full payment required 3 days prior.

CATERING REQUIREMENTS | A minimum of 20 guests are required for all memorial catering packages and individual catering orders. Three (3) business days' notice is required for all memorial function catering selections. Any additional catering orders or additional dietary requirements placed on the day incur additional costs. Payment for additional catering and special dietary needs requested on the day is required upon conclusion of the event. Prices may be subject to change, and in such cases every effort will be made to inform patrons at the earliest opportunity.

CANCELLATIONS I A full refund of the security deposits paid for room hire will be given for cancellations 4 days prior to the function date. No refund will be given for cancellations with less than 4 days notification. Three (3) business days are required for all catering cancellations. Cancellations with less than three (3) business days will be subject to 50% of the catering cost. Cancellations or changes not received and acknowledged within 24 hours of the scheduled function will be charged 100% of items ordered.

CLUB POLICY I Organisers of functions will always be responsible for the conduct of their guests. All Club internal rules must be strictly adhered to, i.e. dress, standard of behaviour, entry/sign-in to the Club. Any specialised cleaning for excessive mess or repair due to damage caused to any function rooms will incur a cost to the Individual/Organisation responsible for the function. The Club will take all necessary care and attention but accepts no responsibility or liability for damage to persons or property or loss of merchandise or equipment left at the Club prior, during or after any functions or exhibitions on its premises.

All functions will be conducted within normal Club trading hours and will cease at close of the Club. Bar trading will cease 30 minutes prior to closing times. Any special requirements for access to the room outside of Club trading hours must be authorised by Club Management.
